

## Appendix A - Planning Committee nominations 2011-04-08-01a

### **Summary:**

- The Board is requested to approve the Local Authority nominations to WNDC planning committees, subject to Secretary of State approval.
- Two nominees from NBC have little or no planning training or experience. Due to the increase in new councillors elected to NBC in May 2011, it is not possible for NBC to nominate more experienced councillors.
- Councillors with no training will receive appropriate planning training from either NBC or WNDC.
- Once approved by Board, nominations are subject to Secretary of State approval.

### **1 Northampton Borough Council nominations to NAPC**

- 1.1 The council have withdrawn their nomination of Cllrs. Dennis Meredith, Brian Markham, Don Edwards and Sadik Chaudhury.
- 1.2 They have nominated the councillors below. Due to the high number of new councillors elected to NBC in May 2011, a number of nominees do not have planning training or experience of sitting on planning committees.
